**Specification:** MIFAB® Series MC-51-LP lacquered, adjustable, ductile iron concealed support arms with locknut, set screws and fixture leveling and locking hardware.

**Function:** Used to secure the fixture to the wall in areas where a floor mounted carrier cannot be installed. Installer must provide their own mounting plate and hardware. The wall structure must be strong enough to bear the weight of the fixture. The vertical load bearing components are concealed within the wall and the fixture carrier has no contact with the finished floor inside of the room.
