

Specification: MIFAB® Series R1200-JD-M-G5H-W31H5 lacquered cast iron large planting area drain with anchor flange, cast iron water proofing membrane clamp ring, cast iron dome with PVC standpipe and stainless steel ballast guard with solid secured cover.

Function: Used to drain water that accumulates on green roof applications. The perforated stainless steel ballast guard prevents vines from entering the drain line.
